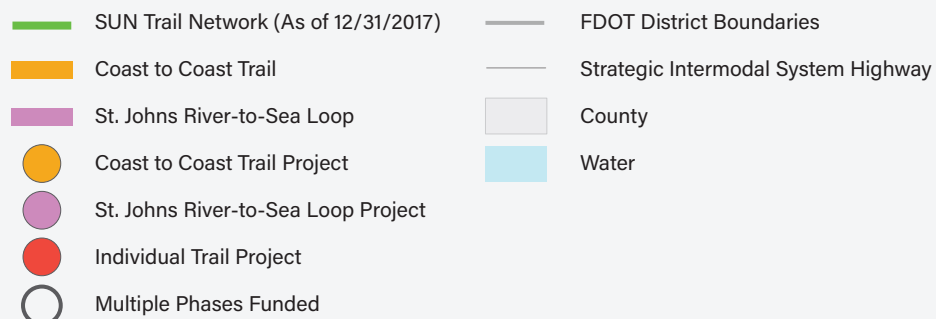

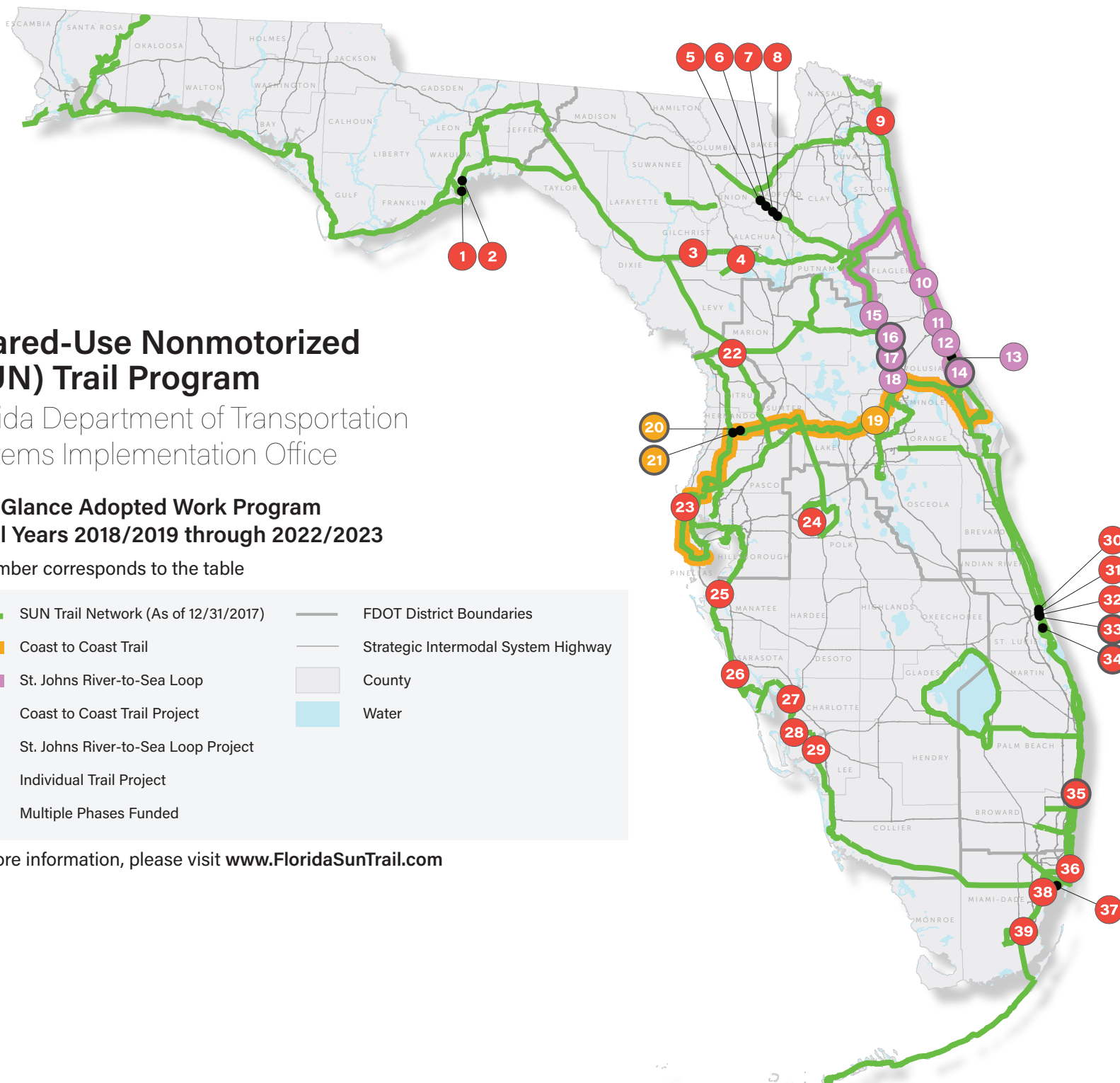

The Preliminary Tentative Work Program encompasses the five years after the current work program year. Two weeks prior to the legislative session, the department submits it to the Florida Legislature, the Executive Office of the Governor (EOG), the Florida Transportation Commission (FTC) and the Department of Economic Opportunity (DEO). The Tentative Work Program is submitted two weeks after the beginning of the legislative session to the Florida Legislature, the EOG, the FTC and the DEO. On July 1, the tentative work program becomes the adopted work program. The first year of this adopted work program becomes the current work program year.

In the Individual Trail category, an allocation to one project phase is not a guarantee of commitment to allocations for future phases;
