

2021 Florida Interchange Access Request Process Training

The Department's Systems Implementation Office (SIO) developed and maintains the Interchange Access Request User's Guide. The purpose of this User's Guide is to provide guidance on how to prepare documents that support requests for new or modified access to the Florida Interstate Highway System, FTE and non-interstate limited access facilities on the SHS. This User's Guide also provides information on the IAR process that shall consider the needs of the system at a regional level while maintaining the integrity of the highway network.

SIO has developed training material to supplement the FDOT's Interchange Access Request User's Guide. The material will include eight videos and quizzes. General concepts to be covered include:

- Introduction to Interchanges
- Interchange Access Request Process and Types
- Programmatic Agreement and Acceptance Authorities
- Methodology Letter of Understanding Content and Documentation
- IAR Reports
- IARUG Safety Analysis Guidance
- IAR Report Review Process
- IAR Report Re-evaluations

This **Virtual Training** will be managed using FDOT-Learning Curve System. This training will be open to district staff, local government, and consultants.
