For drainage structure S-3A, the plans propose a Type 7 manhole with a 7-foot diameter J-bottom (Alt. A); however, the structure would only be four feet in height from pipe invert (12.90) to the manhole top (16.92). Consider utilizing a standard P-7 manhole (Alt. B) to eliminate the need for a J-bottom and to potentially accommodate an 18-inch pipe for P-3 in lieu of a 14"x23" elliptical pipe.

A P-7 manhole will be used. However, the existing flow lines from EX-243 to EX-245 is what dictates the need for an elliptical pipe upstream for P-3. That structure is proposed as cast-in-place due to the shallowness of the pipe and will remain elliptical.

The plans call for S-9 to be a Type 5 curb inlet with a 4'x9' bottom. It is unclear why the structure bottom needs to be 9 feet wide and why pipes P-9 and P-9-1 enter the walls of this structure bottom at different offsets. Consider utilizing a Type 1 curb inlet with a smaller structure bottom and align pipes P-9 and P-9-1 at this location. The revised structure and pipe location could eliminate the need to relocate the 6" PVC water main along the SR 72 outside lane.
