**SECTION T1050
UTILITY PIPE REMOVAL AND DISPOSAL**

T1050-1 GENERAL.

Except as expressly provided elsewhere in the Contract Documents, this Technical Special Provision paid for as "Utility Pipe Removal and Disposal" apply only to the work described as follows, hereinafter referred to as the "Utility Pipe Removal." The Utility Pipe Removal covered by the Technical Special Provision includes but is not limited to removal of out-of-service utility pipelines, valves, fittings, and all other appurtenances required for a complete and acceptable removal of the out-of-service utilities for this work as specified in the contract documents. The work consists of the removal of a 30-inch Ductile Iron (DI) water main. The water main removal is to be completed in conjunction with the FDOT road improvements of I-75 at Daniels Parkway.

T1050-2 REMOVAL AND DISPOSAL.

All Utility Pipe Removal shall be in accordance with the FDOT Standard Specifications for Road and Bridge Construction Section 110, Clearing and Grubbing and this Technical Special Provision.

T1050-3 INTERRUPTION OF SERVICE.

All existing utility pipes to be removed shall be placed out-of-service by the Utility Owner prior to removal.

T1050-4 RESTORATION.

Whenever the site is disturbed solely for the purpose of Utility Pipe Removal, completely replace, and restore the site to the Engineer's satisfaction.

T1050-5 METHOD OF MEASUREMENT.

The quantity to be paid for the Utility Pipe Removal and disposal will be the plan quantity in feet (30-inch pipe) completed and accepted.

T1050-6 BASIS OF PAYMENT.

Prices and payments shall be full compensation for all work specified in this Technical Special Provision.
