



## GENERAL NOTES

- 1. BENCHMARK DATUM IS NORTH AMERICAN VERTICAL DATUM OF 1988 (NAVD 1988).
- 2. THE CONTRACTOR SHALL CLEAR AND GRUB THE PROJECT SITE ONLY TO THE EXTENT NECESSARY TO CONSTRUCT THE PROPOSED IMPROVEMENTS. ANY TREE REMOVAL, CANOPY TRIMMING, OR ROOT PRUNING NECESSARY FOR THE CONSTRUCTION SHALL BE PAID FOR UNDER "CLEARING AND GRUBBING", PAY ITEM 110-1-
- 3. ALL PUBLIC LAND CORNERS AND PRIMARY NETWORK CONTROL SURVEY MONUMENTS ARE TO BE PROTECTED BY THE CONTRACTOR. CORNERS AND MONUMENTS WITHIN THE WORK ZONE AND IN DANGER OF BEING DAMAGED, DESTROYED OR COVERED SHALL BE PROPERLY REFERENCED BY A REGISTERED LAND SURVEYOR IN ACCORDANCE WITH THE MINIMUM TECHNICAL STANDARDS OF THE FLORIDA BOARD OF PROFESSIONAL LAND SURVEYOR PRIOR TO THE BEGINNING OF WORK. SUBMIT CERTIFICATIONS PRIOR TO THE PRE-CONSTRUCTION MEETING.

2. ITEMIZED COSTS.

PRIOR TO THE PRE-CONSTRUCTION MEETING, SUBMIT TO THE ENGINEER, THE COUNTY'S REPRESENTATIVE, AND THE DISTRICT'S LANDSCAPE ARCHITECT A UNIT COST BREAKDOWN FOR EVERY ITEM OF WORK INCLUDED FOR THIS PROJECT.

3. PLANT REMOVAL:

INSTALL NO MATERIALS THAT WILL BLOCK OR CREATE CONFLICTS WITH SIGNS, BILLBOARDS, LIGHTS, OVERHEAD AND UNDERGROUND UTILITIES, ACCESS WAYS, GATES, FIRE HYDRANTS, FPL RIGHT TREE/RIGHT PLACE SETBACKS, FDOT MAINTENANCE RATING PROGRAM AND ANSI Z-133 UTILITY CLEARANCE REQUIREMENTS. INSTALL TREES, PALMS AND SHRUBS A MINIMUM OF 7 FEET FROM ANY FIRE PROTECTION EQUIPMENT OR DEVICES. IMMEDIATELY NOTIFY THE ENGINEER. 5. SOIL BACKFILL MIXTURE:

SOIL BACKFILL FOR THE INSTALLATION OF ALL PLANT MATERIALS SHALL BE A UNIFORM MIXTURE OF 25% DECOMPOSED COMPOST AND 75% EXISTING SITE SOIL, CLEANED FREE OF WEEDS AND ROCKS 1-1/2 INCH OR GREATER. PRIOR TO THE PRE-CONSTRUCTION MEETING, SUBMIT COMPOST MANUFACTURER'S CERTIFIED ANALYSIS TO THE ENGINEER, THE COUNTY'S REPRESENTATIVE, AND THE DISTRICT'S LANDSCAPE ARCHITECT FOR APPROVAL. 6. WATERING:

DURING PROJECT INSTALLATION AND THE 1 YEAR PLANT ESTABLISHMENT PERIOD, KEEP THE SOIL MOISTURE AT ALL PLANTING AREAS AT FIELD CAPACITY. 


