- 3. Clarification of List of Projects in District 6 released by FTBA on Oct. 6, 2021. Only includes projects in FY 2022 and this is not a list produced by FDOT.
- 4. FDOT made a single announcement in Tampa, FL and District 6 received funding for projects in FY 2022, 2023 and 2024. Some highlighted upcoming projects, include:
  - a. FY 2023 will include Golden Glades Intersection in a "lite" version with the same design, but without related SR 826/Palmetto Expwy components due to FGC potential conflicts and limitations.
  - b. Monroe County will include 3 projects on SR A1A / Roosevelt.
  - c. Various pedestrian safety and signalization projects.
  - d. Long Key Bridge
  - e. 7-Mile Bridge Replacement (FY 2028). Complex PD&E project will be required.
  - f. Various operational improvement & strategic projects at I-95. No capacity improvement projects.
- 5. Funding sources were discussed, including CRRSAA, ARPA, and IIJA.
  - a. No affect to industry and the funds management is the Department's coordination and responsibility.
  - b. Concern on Miami-Dade and Monroe counties' number of projects was clarified and plenty of work is planned in subsequent years of the upcoming work program.
- 6. ACEC-FL Update on Alternative Contracting Task Force related to Design Build process based on recent ASDBs.
  - a. Most recent projects have been special cases, with special requirements, hence not good examples for a benchmark.
  - b. Discussion on risk sharing and quality of informational documentation provided (e.g., surveys, Geotech reports, etc.)
  - c. Improvement in feedback provided to Consultants through ATCs. ACEC-FL committee suggested "sit-in" sessions.
  - d. DB process is being discussed at CO-level and changes to the process will be coming.
  - e. D6 has no major DB projects upcoming.
