- 2. Approval of Meeting Notes from October 26, 2021. No outstanding issues.
- 3. District confirms no changes or updates to Work Program's Consultant Acquisition Plan (CAP).
 - a. Communications on-going with County & TPO for next Tentative Work Program.
 - b. GGI project will come through Governor's Office funding.
 - c. No IIJA allocations until next Work Program.
- 4. IIJA provided additional \$500M yearly in Work Program; \$245M to bridge program; Department has not been successful at obtaining funds from discretionary (grant) programs. Discretionary program funds may go directly to local agencies; fund management to be determined by corresponding Federal agency. More information to come.
- 5. Staffing capacity to delivery a larger Work Program
 - a. Consultant industry offering more telework options to retain and raising salaries. Also, not focusing solely on civil engineering, but other engineering disciplines, and project manager skills (e.g., PMP)
 - b. FDOT has a hybrid telework program; raising salaries is not an option. Employee retention is a hot topic at FDOT as there are not enough engineers in the industry. Internship programs at high school and college level.
 - c. Secretary states that the "goal is to grow the industry together".
- 6. Cost increases to contractors
 - a. Result in some projects above budget
 - b. Department states that this trend is not consistent due to D6 being a competitive District.
- 7. CEI and 3D/AMG Projects
 - a. All design projects in 3D; District has 1 pilot project for streamlining plans
 - b. CEI scope is not clear regarding 3D expectations
- 8. Progressive Design Build
 - a. District has no experience using this procurement method; however if it becomes available Leadership will consider applying this method, where appropriate.
 - b. FDOT may already be beyond this methodology and current FDOT Adjusted Score Design Build method is superior to Progressive Design Build.
