 - iv) Bridge program is not for on-systems structures
 - v) A week after April 12, 2022, the Program & Resources Plan starts, and it takes about 3 months.
- 5. Staffing availability concerns delivering larger Work Program
 - FDOT met with Miami-Dade College to promote the internship program, including for non-engineering areas.
 - ii) Potential idea: high school shadow days and reaching out to additional colleges and universities for career fairs
 - iii) An activity that is restarting in District 4 is Construction Career Day. Potential idea for District 6?
- 6. Changing of Staff Job Classifications after contract execution
 - i) Currently, we are not able to adjust rates due to staff promotions, salary increases or years of experience. The classifications are determined by the resumes submitted at the time of new contract negotiations.
 - ii) Afterwards, if the staff member receives a promotion, they can do the work of the higher-level classification if that classification is on the contract.
