 - a. Design-Build Projects:
 - i) Increasing risks to designers and contractors. Majority of design-builds have been ending in lawsuits between designers and contractors (causing some companies to steer away from them). Contractors have generally been losing profits, so they try to recover costs through insurances, claims to the designers/FDOT. Changes in utilities/permitting agencies have dampened the relationships.
 - ii) Talks of new format with just one 90 min ATC meeting. District and ACEC-FL not in favor. Proposing alternatives for consultant to receive faster feedback from Department.
 - iii) Technical scoring inconsistency (also applies to traditional design) is discouraging consultants. Progressive Design Build would be a step backwards, although if available would be considered.
 - b. Cost Saving Initiatives/Alternative TTCP:
 - i) Receptiveness to new ideas: "why do it?" vs. "why wouldn't we do it?"
 - ii) Distribution of funds (applied to other projects)
 - c. "Adopt a Community" initiative similar to "Adopt a Highway" synergizes with Secretary Perdue's message on focusing on the community. Quarterly events to recruit for the future. Pledge includes 2-year programming phase, community outreach once per quarter to community stakeholders, partner with industry organizations, Target Zero safety message.
 - d. Lack of Standards for Transit Improvements
 - e. Construction Costs
