FC-5 Replacement Milling and Resurfacing Pavement Only Low Bid Design-Build in Hillsborough County. The intent of this Low Bid Design-Build project is to replace existing raveling FC-5 Friction Course with new FC-12.5 Friction Course from S Falkenburg Rd. to Lake Kathy Dr. for a total project length of 0.93 miles. The scope of work requires the replacement of the FC-5 Friction Course and pavement markings that will be impacted by the milling and resurfacing. Other improvements, including cross slope correction, RRR improvements, and ADA improvements, are not included in the scope of work.
