- 2) Section 1.12 is replaced as follows:

All materials submitted in response to this RFP and accepted will become a public document pursuant to Chapter 119, Florida Statutes. Proposals will be opened on July 22, 2020 at 3:00 p.m., Eastern Time.

The Proposal opening will be held by GoToMeeting in lieu of an in-person meeting since the Burns Building is currently closed to the public.
