I'd like to make the following suggested change to the proposed 5-9 language: 5-9.1 Cooperation by Contractor: Do not perform work or furnish materials without obtaining inspection by the Engineer. Provide the Engineer with safe means of access to the work, so the Engineer can determine whether the work performed and materials used are in accordance with the requirements and intent of the Contract Documents. For bridge projects with construction operations accessible only by watercraft, provide safe and [timely] passage and transport to facilitate the Engineer's inspection of the Work. Reason: I think there should be some emphasis placed on access being provided in a timely manner. The goal is to ensure that watercraft transportation is provided promptly when it is needed. The old SP this is replacing required boats to be provided at all times. Adding the timely requirement addresses this in the replacement 5-9 specification.
