SUBJECT: MANDATORY SPECIFICATIONS REVISIONS

July 2021 Workbook and eBook: Mandatory Revision No. 1

Mandatory No. 1 is issued to include the following Standard Specification for lettings beginning July 1, 2021, and forward.

Senate Bill 1194 introduces language in Florida Statute 337.0262 prohibiting the Department of Transportation and contractors and subcontractors of the Department from purchasing specified substances from a borrow pit unless the following conditions are satisfied:

- (a) Certification is provided to the Department, contractor, or subcontractor by the operator of the borrow pit that it is in compliance with the notice requirements and substantive requirements of s. 378.801; and
- (b) The operator of the borrow pit is in compliance with the performance standards in s. 378.803, including, but not limited to, providing proof of currently valid permits required by the Department of Environmental Protection and the appropriate water management district.

The amendment further requires the Department to cease to accept any substances from that borrow pit within 48 hours if it determines the borrow pit is not in compliance with this section. It further allows the Department to resume acceptance of substances from the borrow pit once the borrow pit is in compliance with this section.
