Discretionary Grants Awarded to Florida LPA's from 2012 to 2023 – 52 awards.

- Types of discretionary awards since 2012, BUILD, SS4A Implementation Plan, TIGER, RAISE, SS4A – Action Plan, RCP (Reconnecting Communities Pilot), ATCMTD, SS4A – Supplemental Action Plan.
- BUILD, TIGER and RAISE grants are basically the same, just changed names under different administrations.
