Mandatory No. 3 is issued to include the following Supplemental Specifications for lettings beginning July 1, 2016 and forward.

Chapter 2016-181, Laws of Florida (formerly House Bill 7027) was signed by the Governor on April 4, 2016 and will be effective July 1, 2016. Included in the implemented language is the creation of Section 337.027, Florida Statutes, related to the Department's Business Development Program. Previous statutory authorization was granted by Section 337.025.
