High Performance Contrast Tape for Skip Pavement Markings on Concrete

Surfaces

**BACKGROUND:** Contrast pavement markings are currently required for skip pavement markings on concrete payement surfaces. High performance tapes are preferred on concrete surfaces because of better adhesion. As a result, it is desirable to use contrast high performance tape on concrete pavement surfaces for skip pavement markings.

**REQUIREMENT:** Contrast high performance tape shall be used for skip pavement markings on all new concrete pavement surfaces, except bridges, on projects with a minimum of ½ mile of skip pavement markings.

**IMPLEMENTATION:** Effective on all design-build and design-bid-build projects scheduled for letting beginning in January 2012 with new concrete pavements meeting the requirements above.

The Plans Preparation and Basis of Estimates manuals will be updated to reflect the above requirements.

**Update RFPs for design-build projects:** Include language in the RFP to require contrast tape for skip pavement markings on concrete pavement surfaces (except bridges).

**Update Plans and Pay Item Notes for design-bid-build projects:** Update the tabulation sheet quantities and the Proposal Summary of Quantities (Trns\*port report) in the plans.

## **Pay Items Update:**

The following pay items will be available for contrast tape skip pavement markings:

## 713-1AA-BCD Pavement Marking – Preformed Tape

AA= 02 (High Performance)

B= 5 (White w/Black Contrast)

C= 3 (Skip) GM

4 (Skip) LF

D= 3 (9") valid for 6" white/black contrast applications only, B=5

7 (11") valid for 8" white/black contrast applications only, B=5

(no longer valid for new projects; use 15" width)

8 (15") valid for 12" white/black contrast applications only, B=5

(D=8 will be used for drop lanes only)

**Specifications:** No change in specifications required.

CADD/Quantity Manager: No changes needed.
