All other implementation of the manuals listed above is effective on all projects beginning design on or after January 1, 2025 and on projects currently in the design phase where implementation will not adversely impact production schedules.

Changes implemented via Roadway Design Bulletins issued between December 2023 and November 2024 are incorporated into these manuals. These changes are effective as described in their respective Bulletin.
