COMMENT:

Upon review of section 17345 Interchange Markings – Exit numbers, we have noticed that Note #2 (from 17346) that specified "the thickness of the preformed message shall be 125 mils" has been removed.

Was this omission of the preformed thermoplastic thickness intentional to open these contrast exit numbers up for other marking types? Other marking types may not give the same crisp clean appearance or longevity of preformed thermoplastic. We understand that the minimum specification thickness of preformed thermoplastic markings in Florida is 125 mils, so that may be why it was removed, but the proposed wording no longer specifies preformed thermoplastic for the contrasting exit numbers.
