- 1) These changes were proposed by Juanita Moore in the State Contracts Administration Office to revise the timeframe for submittal of questions for December lettings. The standard deadline for submitting questions is the seventh calendar day prior to letting. For December lettings, this is the Wednesday before Thanksgiving with responses posted on the following Monday. For the December 2009 lettings, the Contracts Office sent a letter to bidders encouraging them to submit questions prior to the deadline. The revised language eliminates the need for the letter.
- 2) These changes were proposed by Brian Blanchard, Chief Engineer to comply with a new state law, effective July 2010, requiring contractors to give preference to state residents when hiring for state funded contracts. For July and August 2010 lettings, the contracts offices will provide the language in the contract to avoid supplemental specification packages.
