CONCRETE PAVEMENT SLAB REPLACEMENT. (REV 10-7-13)

SUBARTICLE 353-9.1 is deleted and the following substituted:

353-9.1 General: Construct transverse joints as specified in 350-12 and as shown on the Design Standards, except that dowels bars are installed per 353-9.2. Tie bars will not be placed along the longitudinal joints unless shown in the Contract Documents. Apply a liquid bond breaker recommended by the manufacturer for the intended application to all vertical faces of the adjacent slabs.

Clean and seal joints in accordance with 350-12.

ARTICLE 353-11 is deleted and the following substituted:

353-11 Method of Measurement.

The pay quantity will be the volume, in cubic yards, of concrete placed and accepted determined by calculation. The quantity will be calculated using field-measured horizontal dimensions and thickness of the removed slab. *The pay quantity for cleaning and sealing joints will be in accordance with 350-17*.
