### Summary:

1. Remove language requiring Notarized Certification Statement (also known as 105, 449, 450 letters) and instead rely on preexisting requirements for the Production Facility Quality Control Stamp and the delivery ticket. 2. Remove non-metallic fastener mockup requirements.

### Justification:

Notarized Material Certification requirements are redundant when Production Facility Quality Control Stamp and delivery tickets already certify product compliance with department specifications. In addition, the delivery ticket contains Section 6 compliance verbiage.
