**705-2.1 General:** Meet the following requirements:

SUBARTICLE 705-2.4 is deleted and the following substituted:

705-2.4 Retroreflective Sheeting: Use Types IV, V or XI sheeting. The retroreflective area shall be in accordance with the MUTCD.

**705-2.5** <u>4</u> Aluminum Panel: For Object Markers and Nonflexible Delineators, adhere retroreflective sheeting to 6061 T6 aluminum meeting ASTM B209. Use 0.040-inch sheet aluminum for Type 2 markers and nonflexible delineators. Use 0.080-inch sheet aluminum for Type 1, Type 3, and Type 4 markers. Prepare aluminum in accordance with recommendations of the sheeting manufacturer.
