The Florida Department of Transportation has been working on routings for US Bicycle Route 1 and US Bicycle Route 90 in Florida for the past two years. We plan to submit applications to the AASHTO US Route Numbering Committee to establish these routes this Fall. The deadline for submitting our applications for consideration at the 2014 AASHTO Annual Meeting is October 6, 2014.

It is our understanding that it is not necessary for the Georgia DOT to adopt routings to extend US Bicycle Route 1 into Georgia at this time but we do need your concurrence on our proposed crossing point at the Florida-Georgia State Line. That crossing point is at US Highway 1 at the Florida-Georgia State Line.

Resolution of Support For U.S. Bicycle Route 1 through the County of Miami-Dade

WHEREAS, a national network of bicycle routes which will link urban, suburban, and rural areas using a variety of appropriate cycling facilities is under development across the United States; and

WHEREAS, the American Association of State Highway and Transportation Officials (AASHTO) has designated a corridor generally along U.S. Highway 1 in Florida to be developed as United States Bicycle Route 1 (USBR 1), and

WHEREAS, the Florida Department of Transportation has adopted a *Policy on U.S. Numbered Bicycle Routes* calling for the establishment of USBR 1 in Florida; and

WHEREAS, a route that departs from U.S. Highway 1 between the points shown on the accompanying map is recommended as a preferable route for cyclists for USBR 1 passing through the County of Miami-Dade and can therefore provide a benefit to our residents and businesses, and

WHEREAS, we have investigated the proposed route and found it to be a suitable route, and desire that the route be designated so that it can promote bicycle tourism in our area.

THEREFORE, BE IT RESOLVED, that the County of Miami-Dade hereby expresses its approval and support for the development of USBR 1, and requests that the appropriate officials see to it that the route is officially designated by AASHTO as soon as this can be achieved.
