SUMMARY OF REVISIONS

- **Chapter 2 Signs**
 - o Section 2.6.1 BRIDGE AND SIGN STRUCTURE LOW CLEARANCE SIGNS: First paragraph modified to clarify location of sign placement.
 - o Section 2.15 SMOKE ON HIGHWAY SIGNS: Entire section updated.
 - Section 2.29 USE OF FLUORESCENT YELLOW-GREEN SHEETING: Entire section rescinded and the language is now included in the FDOT Standard Specifications for Road and Bridge Construction Section 700.
- **Chapter 3 Signals**
 - Section 3.4 EMERGENCY TRAFFIC CONTROL SIGNALS: Updated Figure 3.4-1 and eliminated Figure 3.4-2 by incorporation to improve comprehension and legibility.

- o Section 3.7 ACCESSIBLE PEDESTRIAN SIGNALS: Entire section updated; updated change from 'audible' to 'accessible' language.
- o Section 3.8.3 DEFINITIONS: Updated the following definitions to agree with MUTCD definitions: Marked Crosswalk, Midblock, Pedestrian Hybrid Beacon, Two-stage marked crosswalk, Uncontrolled approach, Unmarked crosswalk.
- Section 3.8.5 INSTALLATION CRITERIA AND CONSIDERATIONS: Modified paragraph (3)(b) threshold language.
- Section 3.8.5 INSTALLATION CRITERIA AND CONSIDERATIONS: Modified paragraph (5)(d) to include two-stage crossings.
- o Section 3.8.6 PEDESTRIAN CROSSING TREATMENTS: Modified paragraph (4)(a) to agree with MUTCD 4D.01 for mid-block crosswalks.
- o Section 3.8.6 PEDESTRIAN CROSSING TREATMENTS: Modified paragraph (4)(c) to include crossings with median refuge islands.
- o Section 3.8.6 PEDESTRIAN CROSSING TREATMENTS: Modified paragraph (6)(a) to include language that approval from FHWA for interim use is required for any local agency; updated policy memorandum number IA-11 to IA-21 since IA-11 is terminated.
- Section 3.8.7 SELECTION GUIDANCE FOR PEDESTRIAN
 TREATMENTS: Modified paragraph (1)(b) to clarify engineering study
 requirements.
- Section 3.10 FLASHING YELLOW ARROW SIGNAL APPLICATION: New section added.
- Chapter 4 Markings
 - o Section 4.5.2 DEFINITIONS: New definitions added.
 - Section 4.6 USE OF INTERNALLY ILLUMINATED RAISED PAVEMENT MARKERS: New section added.
