ITEM 1 Action Items from Previous Meeting

### ITEM 2 Center-to-Center Reliability

• John (OOCEA) provided update: IBI has reconfigured C2C components to spread out processing and alleviate load

### ITEM 3 Expanded User/Device Permissions

- John (OOCEA) provided update: IBI Southwest Research Institute provided more information about Option 1 (\$125K), CMB approved option 1 to move forward with design
- D6 prefers option 2, but will try option 1 to see if it will work operationally

## ITEM 4 Windows Server 2003 Upgrade

• SunGuide R6.0 will require Windows Server 2008 and Windows Server 2003 is reaching end of life, districts should plan on upgrading if they haven't already

# ITEM 5 Database Clustering and Replication

- Brian (CO) stepped through several permutations of database clustering and setting up replication
- Steve (D5) asked about how licensing works for VMWare / virtual environments
  - o Clay: Microsoft will be consulting for each SunGuide deployment
- John (OOCEA) asked if FDOT CO will provide clustering standards/recommendations
  - o Arun (CO): No, each deployment is unique

### ITEM 6 PostgreSQL

- Clay (CO) reviewed PostgreSQL, a free database management software
- John (D3) Is Server 2008 enterprise version required? Yes
- Mark (D6) Does it support bulk inserts Yes

### ITEM 7 Cloud Computing

• Clay (CO) briefly touched upon this, more to come

### ITEM 8 IE9

- John (OOCEA) asked who's using this and what problems have been encountered
- Several districts have been using it and seen issues with window focus and caching
- Brain (CO): Several issues will be resolved in R6.0 with the use of WFP

• AI: CO will perform IE9 testing at the TERL.

### ITEM 9 Open Forum

- Hotfixes, is there an easier way of accessing these?
  - AI: Clay (CO) will investigate better ways of accessing hoxfixes from the SunGuide website
- Mark (D6) Requested update about install process
  - o Clay (CO) in the process of producing ConOps for install process
  - Nathan (D5) Always issues with the software being installed, SwRI is always required to be there to address issues as they are found
    - i. D5 DB staff not available and training may not be possible due to budgets
  - o Mark (D6) When we have differences, it means we need an expert to adapt the installation to accommodate these differences.
  - John (OOCEA) one of the suggestions was to analyse the environment to make sure the dependencies.
  - o Mark (D6) we have an installation document that covers:
    - i. places we have things saved
    - ii. things we've done before
  - o Clay (CO) D6 also has complete dry run of the installation.
  - o Jessica (OOCEA) We also had a hard drive fill up after 5.1.1 installation
    - i. supports standardization of hardware
  - Steve (D5) Moving archive log files go into a folder on the SAN; originally
     250GB of space; Mary wrote a script to delete files; the LUN was expanded to
     600GB; after 5.1.1, the archive logging tripled.
    - i. Mary gave SunGuide support notes to SwRI; SwRI wanted to filter them, and D5 hasn't received them.
