ITEM 1 Data Migration Tool Overview

- FDOT CO developing survey asking how SunGuide systems are connected to external systems
 - o Derek sent out survey on 12/12/13

- o **AI**: John will forward SunGuide configuration survey to all SSUG members
- ConOps for desired IDS changes
 - o Derek sent email on 10/18 requesting feedback
- TSS Gap Data Retrieval ConOps
 - o To be sent out SSUG in coming weeks
- FTE will inform CO if FTE is ready to install 6.0
 - o Open, no update
- FDOT CO will send out a link for new Navteq map data
 - o Derek sent link on 12/17/13
- Clay will get with Joe and Javier offline to discuss protocol of their beacons (paging)
 - o Joe: Will discuss how to incorporate into RPG
 - o Action item open
- Clay will get with Mark to brainstorm making a common IDS interface and Mark will provide a bulleted list of initial ideas of an IDS interface
 - o Open, no update

ITEM 2 Vote for new SSUG Chairman

ITEM 3 Open Forum

- Mark Laird FP 1957 email messages in RPG
 - o Currently, info in email messages doesn't change
 - Enhancement: updates to event should automatically update timestamps, blockages, congestion
 - Multiple emails would be sent throughout life of event
 - May also consider adding an email template for message and subject
 - AI: Mark will set up working group with who uses emails most (D6, D4, FTE, and MDX) to discuss enhancements to email messages in RPG
- Mark Laird FP 2640 time change issue

- o D6 needs to manually correct timestamps in reports
- Joe daylight savings should be abolished
- May need to discuss this issue further
- **AI**: SSUG will revisit FP 2640 related to fixing timestamps in reports spanning daylight savings dates
- Dee issue with reporting duration for specific cases
 - o Boat was abandoned for 2 days, then blocked right lane to remove boat
 - Reported lane blockage time was extremely long
 - o FP 1912 covers lane blockage, lane clear, then lane blockage again
 - o Clay Currently works as designed
 - o Joe but cannot handle discontinuous blockage
 - Clay Perhaps present changing the event type and/or exclude outliers from reported average lane clearing timelines
 - AI: D4 and D6 will send scenarios and chronology reports to Clay so that FDOT CO can better understand issues
- Mark Laird Has R6.0, patch 2 been released?
 - o D4 is waiting on official patch 2
 - o Derek Will be available shortly
 - Jared Have there been issues for D5?
 - Josh No major issues except SQL transaction logs need more space
- Derek Is everyone receiving FHP CAD alerts?
 - Still down for D7 and D2
 - o D5 changed IP for FHP interface
 - o **AI**: D5 will coordinate with D7 to D2 to provide new IPs for FHP CAD alerts
 - Josh if there are issues with FHP CAD, how should D5 inform other districts?
 - Clay D5 should contact FDOT CO, and CO will communicate with other districts
 - AI: FDOT CO will open up conversation with FHP to discuss better coordination between FHP and FDOT for upgrades and issues
