### **ITEM 1** Action Item Review

- Standardized IDS development
  - No action, Action Item On Hold
- Mark to set up working group who uses email the most
  - o No action, Action Item On Hold
- FDOT CO will work on upgrading FHP interface
  - o FP 1734: Included in small enhancements discussion
  - Clay Packard: We are not able to get the feed changed; however, we will
    discuss an alternative solution in the Small Enhancements to mitigate the
    direction issue.
    - Recommends closing this for now, and revisiting this if needed after the proposed enhancement has been built and deployed to see if the enhancement meets the need sufficiently
  - o Will be tracked with small enhancements bundle, Action Item Closed
- FDOT CO discuss cost of transitioning to UTC timestamps
  - FP 2640: CO requested more info, may need to manually enter timestamps at times, will discuss further
  - We have requested more information on how this would work in SunGuide at the end of the following discussion:
  - Some fields allow operator entry of the time something happened not necessary just a click for "now" (i.e. RR calls in and says FHP arrived 15 minutes ago). It'll be tricky to figure this out.
  - o Roger prefers UTC everywhere, but this is a major change and there is lots of old data.
  - **AI**: Roger Stain will make a list of item areas impacted by converting to UTC time
    - Action item is at a low priority.
  - o Action Item Open
- FDOT CO will work with SwRI to update Computer Sizing Document

- Still working on document updates, this is almost ready for distribution for SSUG review, Action Item Open
- FDOT D5 will further discuss facilitating sub-technical group
  - o No action, Action Item Open
- FDOT CO will pursue enhancement to change C2C TSS links to a "no data" state after a globally configurable time
  - o FP 2989: Included in small enhancements discussion
  - o Will be tracked with small enhancements bundle, Action Item Closed
- All districts should think about what new operator performance reports may be needed and send descriptions to Brian Ritchson
  - o Received input from FTE, still receiving input, Action Item Open
- John Hope will contact districts who still need to complete the SunGuide Performance survey
  - Completed surveys received from all districts except FTE and MDX, Action Item Closed
- John Hope will provide the SSUG a diagram how CFX Data Server determines upstream / downstream travel time links
  - Still working on diagram, Action Item Open
- FDOT CO will look into adding a year to vehicles involved and incorporating year into DMS templates
  - o FP 2223: Included in small enhancements discussion
  - Will be tracked with small enhancements bundle, Action Item Closed
- FDOT CO will revisit the updating of new vehicles process
  - o Reassign action item to Mark Laird, Action Item Open

# **ITEM 4** FP 2507 Display Coordinates vs Actual Coordinates

- Clay stepped through presentation material
- AI: Clay Packard to look into comments received during SSUG meeting with SwRI and schedule a separate design review meeting with the SSUG
- Ideas discussed during SSUG meeting included:
  - o Replace the expanded bubble with a magnifying glass showing the map
  - Make collapsed bubble translucent to the map
  - Use the translucent color that is appropriate for conditions such as congestion, alerts/alarms, events, etc.
  - o Require that icon access remains consistent in the expanded bubble as it is on the map outside of the bubble (VOD, right-click, tooltip, etc.)
  - Bubble expands on hover and collapses when no longer hovered (maybe after 1 second).
  - o Icon configuration to include options that affect if/how icons are grouped or remain on the map, such as zoom threshold, etc.
  - Make it operator friendly operators don't know zoom levels, they just know about zooming. Have them zoom to the desired level and then a button that says, "Use icon grouping at this zoom level zoomed out" instead of asking for a zoom level number.

- Preserve vertical space
- o Add to FP 1734: Ensure saving is not required
