Paul Clark welcomed everyone to the meeting and asked attendees to introduce themselves to the group.

Paul announced that Florida’s FY2012 CVISN grant application was successful and Florida has been awarded \$1,000,000 under this grant. He is hoping that he can get budget authorization for the projects in this grant by 4/1/2013 but at the latest by 7/2012.

PROJECT UPDATES

Pre-Clearance at Motor Carrier Compliance Weigh Stations

Sharon Easley reported for Keith Westphal on the PrePass activity report for the past two months. The entire report is included in the appendices.

July 2012: 459,015 bypasses, 123,383 pull-ins with 96% uptime

August 2012: 458,436 bypasses, 139,364 pull-ins with 95% uptime

Pre-Clearance at Department of Agriculture Sites

Major Tim Rutherford reported on applications to join AgPass. The statistics for August 2012 are shown below.

Dept. of Revenue BOL Program

Lynn McElroy reported that she has been promoted to a new position where she now manages 200 direct reports. The first thing she did in this new position was to meet with her direct reports and to stress the importance of the CVISN program. She also noted that DOR is implementing Bills of Lading (BOL) on race horses. The reason for this is that if the animal is not being used for breeding purposes the sale is taxable. This distinction will be noted on the BOL. Current statistics for BOL collections are included in the appendix.

Electronic Credentialing (IFTA¹, IRP²) System Usage Stats

David Helton reported HSMV is taking soft steps to encourage usage of the electronic credentialing system. For the next set of mailings for IFTA renewals they will provide options for this process of mailing it in or renewing online. The option of renewing at the counter is no longer printed on the insert. He noted that the smaller companies may take the option of having a service process their transactions; they are willing to pay the fee for this service (vs. the large carriers). David also reported that the usage of the electronic credentialing system is still increasing. The report is included in the appendix.

Port-of-Entry Study (POE)

Richard Easley reported on the draft document that is now complete. He provided an overview of the preliminary findings.

Don Skinner asked where the revenues go. For citations these funds go to the Transportation Trust Fund; for the Oversize/Overweight citations this goes to the Maintenance Department.

Paul Clark reported that at the Commercial Vehicle Review Board about 20 to 30% of the appeals are cases where they are not apportioned for Florida but don't know it. The cost for a ten-day trip permit is \$30 for the permit fee plus \$30 for the wire transfer fee.

The group discussed that it might increase compliance if the offenders know they could pay a small fee to be legal versus the chance of getting a very large fine.

Paul noted the goal is to make a decision of go or no-go to changing to a POE state and if the decision is to change to begin preparing the wording packet for the 2014 legislative session with a 1/1/2015 effective date. David Helton agreed that the most realistic effective date would be 1/1/2015. David also noted he would also like to get input from HSVM FHP/CVE on the change and implementation. Tisha asked who sets the fee and if the state could limit the amount of the fee.

Container Number Database (CNDB)

Clay Packard reported the draft Concept of Operations (ConOps) was sent out and he received a lot of good comments. These have been incorporated into the document and it has been delivered to Paul Clark. The system requirements are being developed based on the final ConOps document. They have also started work on the system design document and they are making good progress.

CVE LPR System Update/PRISM Project

Clay reported that the project group decided that this would not require a GUI to be installed on users' PCs but rather it will be a central system. The interface will be via a website, the system will send out an email when there is an LPR of interest detected, or if a vehicle on the PRISM Target file is detected. Data and system resources for this project will also be hosted by Paul Clark/FDOT on the CNDB server.

LPR System Hosting (O&M) Update

Paul Clark reported that this system has been moved to the CVISN server at the TERL. A mirror of the data base will remain at the Northwood center so enforcement will have access to this information.

TRUCKING INDUSTRY UPDATE

Tisha Keller reported they are working on the Florida Freight Mobility Trade Plan. Mary Lou Rajchel is working on legislative issues for the next session. Florida Trucking Association (FTA) held their Driver appreciation and also voluntary inspections at the Flagler (I-75 NB & SB) stations.

Tisha also reported they are working on a quick start guide to trucking for those that are new to the industry. This would provide information on where to get permits for example; all of the needed information in one place for the user to access.

CVISN GRANT FUNDING

Paul Clark reported that the FY2013 CVISN grant for \$1,000,000 is now available. Florida is planning to submit one or two large projects rather than several small projects since there are currently so many projects that are underway under previously awarded grants. Paul wants to get all of these finished up before Florida starts on additional projects of this size.

With no further items for discussion, the meeting was adjourned at 3:05 pm.

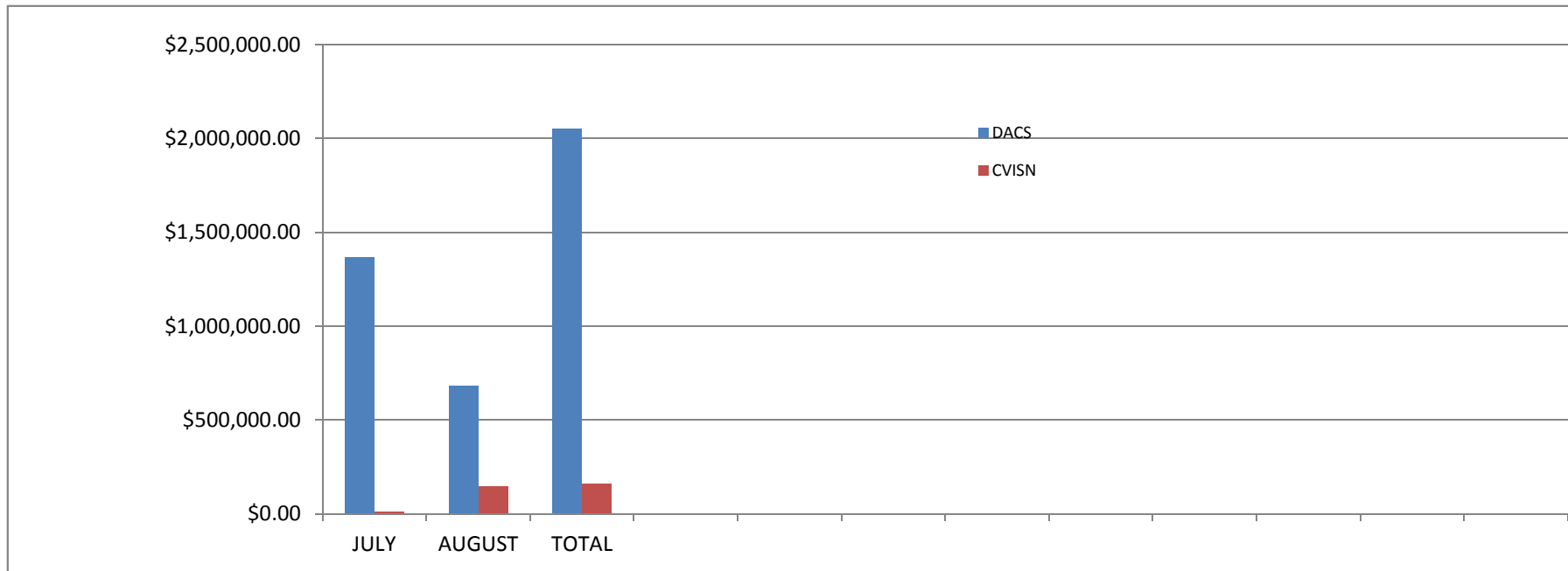

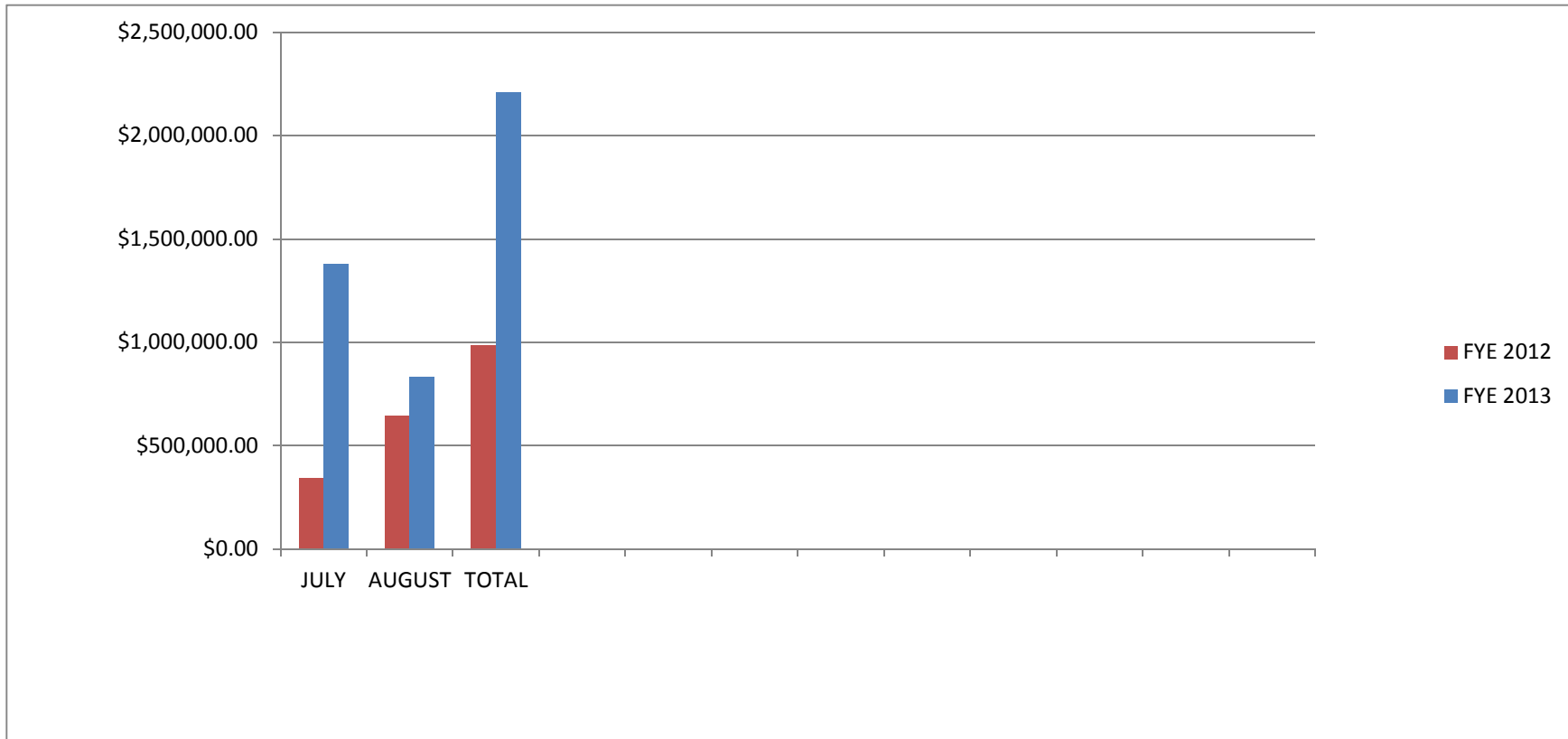
