AGENDA ITEMS:

Welcome and Introductions

Marie Tucker welcomed everyone to the meeting and everyone went around the room/phone and introduced themselves. Marie mentioned that Paul Clark has taken a new role as Statewide Scales Operation Manager.

Current Project updates and/or discussion

Pre-Clearance at Motor Carrier Compliance Weigh Stations

During the past quarter, year over year, the total PrePass activity has increased. At the current rate, this will surpass the previous year's total.

Drivewyze has maintained its upward trend in both bypass and pull-in activity numbers.

Pre-Clearance at Agriculture Sites

AgPass bypass and pull-in activity are higher year over year. Current numbers will surpass 2014. Drivewyze activity has also shown a substantial increase from the previous quarter. Drivewyze technical problems have been resolved. Department of Revenue conducted in-service training.

Automated Permitting System Utilization

As shown in the meeting handouts the number of registered internet subscriber account (ISA) users has been increasing throughout the year. Also, the total number of applications processed has increased along with the permit processing for overweight applications.

Grant project status: The project was sole sourced with the objective to get clean bridge data. The system will now provide exit numbers. Full automation is expected next year in June. In house application processing will be required if engineering analysis is needed, typically, on overweight loads.

FHP requested a PowerPoint presentation on the online application process for training purposes. Workshops are slated for the January/February time frame.

Bill of Lading (BOL) Program

Lynn McElroy stated that Ken Richards will be taking over collections for the Lake City / Jacksonville area. The tax collections (Total and CVISN-BOL) is near \$121M.

M. Tucker stated that the Automated BOL project processing system, there will be an Invitation to Negotiate.

E-Credentialing System Usage Stats

Total International Fuel Tax Agreement (IFTA) numbers have been increasing. There was more traffic for some services due to walk-ins. The Percent of Total International Registration Plan (IRP) Supplements transactions through the web have been flat, thus, looking at more outreach to stimulate electronic filings.

MCSAW Grant Projects

For the mainline weigh-in-motion (WIM) project, all of the sites are up and working locally. Integration and software development with Drivewyze is ongoing.

The first kiosks installed in Pensacola is working well. Once PCI compliance is obtained, statewide deployment can proceed.

Automated Thermal Brake System

The system has been installed at the Yulee weigh station SB. The 20 MPH sign has been installed, but speeds still at 26 MPH. Deployment of a speed trailer may reinforce the lower speed requirement.

Upcoming FY16 CVISN Grant

M. Tucker reminded everyone that the FY16 CVISN grant will be released soon and everyone needs to start thinking if they would like to submit grant projects. More information will come once the grant is on the street. Florida Trucking Association (FTA) has already mentioned making some upgrades to Electronic Freight Theft Management System (EFTMS) and the container number database to assist in cargo theft.
