DISTRICT ONE PROJECT OVERVIEW

In FY 2023 and FY 2024, Florida's Turnpike Enterprise continued and/or initiated funding construction of various transportation infrastructure improvements in FDOT District One, with a total value of over \$331 million. Major projects include:

Summary of Projects



Construct Central Polk Parkway from the Polk Parkway / SR 570 to US 17

FPN: 440897-2

The project constructs the first segment of the Central Polk Parkway linking the Polk Parkway / SR 570 at Winter Lake Road / SR 540 to US 17. This approximately 6-mile roadway will be a four-lane, divided, limited-access facility. It will reduce commercial vehicle traffic through Bartow, enhance safety by separating regional through-traffic from local traffic, and provide regional connectivity. Construction of this over \$259 million project began in FY 2023 and the remaining expenditure to complete the project is funded in FY 2027.

It will reduce commercial vehicle traffic through Bartow, enhance safety by separating regional through-traffic from local traffic, and provide regional connectivity.

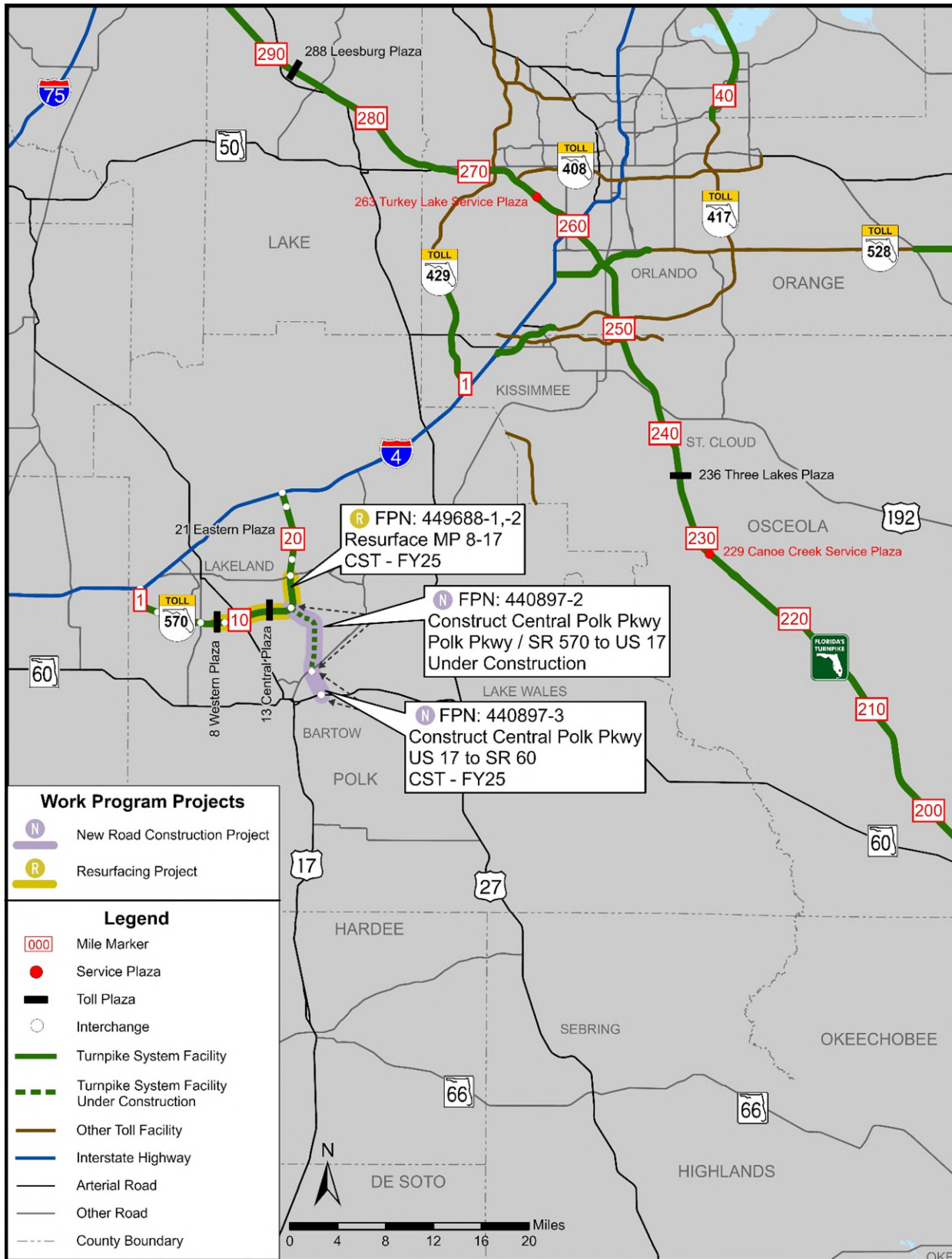

Project Development and Environment (PDE), Preliminary Engineering (PE), and / or Right of Way (ROW) Projects

The table below provides a summary of the projects in FDOT District One that have funding for Project Development and Environment (PDE – Phase 22), Preliminary Engineering (PE – Phase 32), and / or Right of Way (ROW – Phase 43), but are not currently funded for construction in the Tentative Five-Year Work Program (FY 2025 through FY 2029). The projects listed below are not included in the previous funding tables or map. They are each subject to a test of economic feasibility, according to Florida Statutes. The schedule for PE and ROW funding for Central Polk Parkway East projects has been modified to align with the new PDE and Alternative Corridor Evaluation (ACE) Study from SR 60 to US 17/92.
