

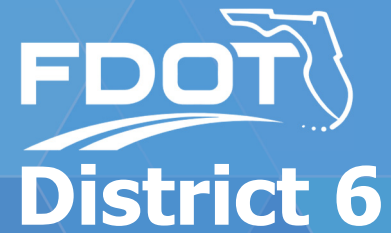

### Summary of Projects



## Overview

Florida's Turnpike Enterprise continues to invest significant funding for transportation infrastructure in FDOT District Six. Since 2013, nearly \$2.4 billion<sup>[1]</sup> has been invested in projects to improve the Turnpike System in Miami-Dade County. This includes funding for major capacity improvements along approximately 41 miles of Turnpike Mainline / SR 821 from SW 312<sup>th</sup> Street / Campbell Drive to NW 57<sup>th</sup> Avenue / Red Road / SR 823 and a new interchange at NW 170<sup>th</sup> Street along Turnpike Mainline / SR 821. Also included are interchange improvements at I-95 / US 441 / SR 826 (Golden Glades) along Turnpike Mainline / SR 91, as well as other safety, maintenance, and operations projects within the county. Major projects are listed in the table below.

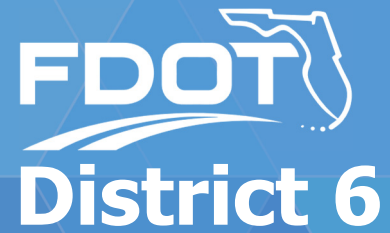

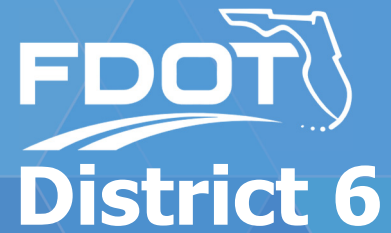

#### Improve Interchange on Turnpike Mainline / SR 821 at US 1 (MP 0)

FPID: 452112-1

The project provides improvements and modifications to the US 1 interchange located at the southern end of Turnpike Mainline / SR 821. Additional turn lanes and intersection improvements, including signalization upgrades, will be made at the ramp terminal connections with US 1. The project will improve traffic operations and enhance capacity.

#### TSM&O | Improve Interchange on Turnpike Mainline / SR 821 at SW 112<sup>th</sup> Avenue (MP 9)

FPID: 453762-1

The Transportation Systems Management and Operations (TSM&O) project provides improvements and modifications to the SW 112<sup>th</sup> Avenue interchange along Turnpike Mainline / SR 821. Additional turn lanes and signalization upgrades will be made at the northbound ramp terminal. The project will improve traffic operations and enhance capacity.

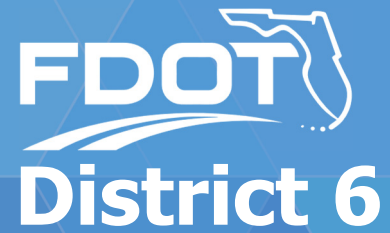

#### Improve Interchange on Turnpike Mainline / SR 91 at I-95 / US 441 / SR 826 (Golden Glades) (MP 0X)

**FPID: 437053-1,-2,-3,-4,-5**

The project provides improvements at the I-95 / US 441 / SR 826 (Golden Glades) interchange at the southern end of Turnpike Mainline / SR 91. The project includes improved northbound and southbound connections between I-95 and Turnpike Mainline / SR 91. The project also includes ramp improvements from Turnpike Mainline / SR 91 to SR 826 and SR 9A. Additionally, Turnpike Mainline / SR 91 northbound ramps from NW 167<sup>th</sup> Street and SR 826, and the southbound ramp to NW 167<sup>th</sup> Street, will be reconstructed. The Enterprise is managing and funding FPID: 437053-5, while other portions of the project (FPID: 437053-1 through -4) are funded by the Enterprise but are being managed by FDOT District 6. This project goes with FDOT District 6 projects, FPID: 428358-1,-4,-8. Construction of this over \$591 million project began in FY 2024 and the remaining expenditures to complete the project are funded in FY 2027, FY 2028, and FY 2030.

#### Widen Turnpike Mainline / SR 91 from Golden Glades Plaza (MP 0.4X) to Miami-Dade/Broward County Line (MP 3.3X)

**FPID: 423373-5**

The project widens a segment of Turnpike Mainline / SR 91 from Golden Glades Plaza to the Miami-Dade/Broward County Line. The widening will increase the number of travel lanes from six to eight. Work includes pavement widening, milling and resurfacing, electronic toll collection gantry replacement, and bridge widening and replacement.
