**Subject:** STIP Amendment No. 10-25 for the Retroactive Authorization of Right of Way Projects

Dear Mr. Knopp:

With this letter and pursuant to the authority delegated to the Florida Department of Transportation by the Governor, I approve the attached STIP Amendment No. 10-25 for previously incurred right of way costs on the listed projects.

In compliance with Title 23 CFR 450.22, I certify that the changes to the STIP were developed in accordance with the applicable requirements of the Federal Transportation Statutes.

On June 22, 2009, FDOT requested your approval for the retroactive authorization of certain costs related to the acquisition of right of way (ROW). Specifically, right of way costs incurred during the period from September 1, 2005, through June 30, 2006, were originally intended to be reimbursed by the issuance of bonds. However, due to poor market conditions the Department was forced to delay issuance of the bonds. The delay resulted in these right of way related expenditures becoming ineligible for bond financing due to the age of the expenditures. The inability to have these costs reimbursed from bond funds is having an adverse impact on the amount of cash needed to support the state funded project commitments in the Department's Five Year Work Program. Your retroactive approval to reimburse these expenditures with federal funds will mitigate this impact and greatly assist the Department with the continued financing of the Five Year Work Program.

On July 12, 2009, you indicated our request would be considered for approval subject to the following conditions being met:

- Any Long Range Transportation Plan (LRTP) and/or State Transportation Improvement Program (STIP) issues are addressed appropriately, and
- For projects with federal aid funds in the construction phase:
  - If construction is completed or is started but more than 50% complete, the ROW Financial Management Information System (FMIS) authorization request would use the date of the original NEPA document, or


- If construction is not started, or is started but less than 50% complete, a NEPA re-evaluation will be required and must be approved by FHWA. The ROW FMIS request would use the NEPA re-evaluation date.

Upon FHWA approval of this STIP Amendment, the Department will have satisfied all the conditions required for your retroactive approval of the ROW expenditures listed on the amendment for federal reimbursement under the provisions of 23 CFR Section 1.9(b) and (c).

We are looking forward to your approval of this STIP Amendment as well as your letter providing approval under Section 1.9 to request federal reimbursement of these ROW costs at your earliest convenience.
